Official information request for the cost of contractors and consultants

I refer to your official information request dated 6 October 2023 for:

The information I seek from each agency is a list of contractor firms, including accountancy and business consultancy firms, that it has used since 1 July 2022, a list of projects that each of those firms has worked on, and a statement of the costs incurred by each agency in respect of each of the firms it has engaged.

Please find attached **Appendix 1** showing contractors and consultants engaged by Te Aka Whai Ora between 1 July 2022 and 31 August 2023. Note that data for September and October 2023 has not yet been finalised and as such, is not included in this response.

Te Aka Whai Ora has been building as an organisation and establishing its teams in a competitive employment market. The use of temporary staff, including contractors, consultants and some seconded public sector kaimahi, has been a temporary measure and has enabled us to meet our obligations under the Pae Ora (Healthy Futures) Act 2022, while we worked towards establishing our operating model and recruiting employees. As you will note, most of the contractors and consultants were engaged to backfill roles that were not yet staffed, rather than a specific project.

Te Aka Whai Ora follows the processes set out under the All-of-Government contractors for external recruitment services.

Te Aka Whai Ora intends to make the information contained in this letter and any attached documents available to the wider public. We will do this by publishing this letter and attachments on our website. Your personal details will be deleted, and Te Aka Whai Ora will not publish any information that would identify you as the person who requested the information.
